

■■ Event Kit: How to Host a Local Property Tax Forum

■ Purpose of the Forum

A Property Tax Forum is a community event designed to educate homeowners, build support for HJR 67, and equip citizens to advocate for lower, fairer, and more predictable property taxes. Your goal is simple: bring neighbors together, share facts, answer questions, and inspire action.

■ Event Overview

Event Type: Community Town Hall / Informational Forum

Length: 60–90 minutes

Host: Local Guardians of Liberty County Chapter or Partner Organization

Audience: Homeowners, local business owners, civic leaders, realtors, and concerned citizens.

Forum Objectives:

1. Explain what HJR 67 (the Save Our Homes Cap Reduction Amendment) does.
2. Show how it helps local families and protects homeowners.
3. Gather petition signatures and recruit volunteers.
4. Encourage attendees to contact legislators and vote YES in 2026.

■ Event Planning Timeline

2–3 Weeks Before the Event:

- Reserve a venue (library, VFW, church, or coffee shop).
- Confirm guest speakers or local leaders.
- Design and share invitations and flyers.
- Download resources: flyers, petitions, and talking points.

1 Week Before:

- Promote daily on social media.

- Confirm speakers and AV setup.
- Prepare materials: petitions, HJR 67 one-pagers, and sign-in sheets.

Day of the Event:

- Set up early — tables, banners, water, and pens.
- Distribute materials and greet attendees.
- Deliver the presentation using the sample agenda below.
- Collect petitions and volunteer sign-ups.
- Take photos and tag @GuardLiberty using #CutTheCreep.

After the Event:

- Thank attendees via email or social post.
- Submit petitions to Guardians of Liberty HQ.
- Report attendance and feedback through the Volunteer Portal.

0:10–0:25 — Overview: What is HJR 67?

0:25–0:40 — The Impact of Tax Creep (local data & stories)

0:40–0:55 — Solutions & Action Steps

0:55–1:00 — Q&A; and Closing Remarks

■ Materials Checklist

- Sign-in sheets
- Printed petitions
- HJR 67 flyers & one-pagers
- Volunteer signup sheets
- Guardians of Liberty banner
- Pens, clipboards, and business cards
- Laptop or tablet for showing campaign materials

■ Tips for a Great Event

- Keep it conversational and citizen-focused, not political.
- Encourage personal stories — they connect better than numbers.
- Always close with a clear call to action: sign, share, and volunteer.
- Follow up within 48 hours to keep momentum going.

■ Reporting Your Event

After the forum, submit your event report through the Volunteer Portal:

- Event name & date
- Attendance numbers
- Petition signatures collected
- Photos or press mentions

This helps Guardians of Liberty track statewide momentum and highlight your impact.

■ What HJR 67 Does

- Cuts the “Save Our Homes” cap from 3% to 1.5%, limiting annual increases in the taxable value of homesteaded properties so taxes can’t outpace income.
- Protects Florida families, seniors, and veterans from being taxed out of their homes.
- Locks in predictable growth for more stable, affordable homeownership.
- Empowers voters by placing these protections directly in the Florida Constitution.

■ Why It Matters

- “Tax creep” is quietly driving property taxes higher each year even without millage rate hikes.
- HJR 67 puts a stop to it — cutting the cap in half to protect homeowners statewide.
- It’s fair, future-focused, and encourages fiscal responsibility while keeping families secure.

■ Key Messages for Homeowners

- “This is about keeping our homes affordable, not freezing local services.”
- “We’re not asking for special treatment — just predictable, responsible taxation.”
- “Government shouldn’t automatically get a raise every time your home value goes up.”
- “HJR 67 keeps more money where it belongs — with Florida families.”
